Board of Education

March 5, 2013

The meeting of the Board of Education was held in the Board room of the Administration Building on Tuesday, March 5, 2013.

President Scott Thompson called the meeting to order at 6:03 p.m. and ascertained that the meeting had been properly noticed on the District's web site and at each of the school buildings. Board members Betsy Ellenberger, Christine Grunwald, Peter Kaul, Christopher Kunz, John Lehman, Steve Lenz, Jeff Spoehr, Scott Thompson, student representatives Jessica Werhand and Luke Nelessen, and the following administrators were present: Mary Pfeiffer, District Administrator; Victoria Holt, Assistant District Administrator of Human Resources & Central Services; Steve Dreger, Assistant District Administrator of Learning & Leadership; Paul Hauffe, Director of Business Services; and Jon Joch, Director of Revenue Enhancements & Business Services Support. The absence of Kirk Leaser was excused. Diane Haug was present as Board Secretary/Deputy Clerk.

As no one present wished to address the Board, President Thompson declared the open forum closed at 6:04 p.m.

APPROVAL OF MINUTES

Motion was made by Betsy Ellenberger and seconded by Peter Kaul to approve the minutes of the February 19, 2013 regular meeting. The motion carried by unanimous vote.
