BOARD OF EDUCATION

CERTIFIED STAFF CONTRACT 2014-2015

IT IS HEREBY AGREED, Between the Board of Education of the Neenah Joint School District, Neenah, Wisconsin and **«FIRST» «LAST»**, a certified staff member by the State of Wisconsin, Department of Public Instruction that the certified staff member is to teach in the subject matter and/or grade level in which the certified staff member is appropriately certified as assigned by the District, pursuant to the following terms and conditions:

- 1. Term. This Agreement commences on the 1st day of July, 2014 and ends on the 30th day of June, 2015 (the "Term"), unless earlier terminated as provided herein.
- 2. Appointment. The certified staff member is appointed by the District for the 2014-2015 school year, for a term (# days) days, as established for the school year and as assigned by the Principal, unless otherwise modified pursuant to the terms of this Agreement. This contract currently is for a **«FTE» FTE** assignment subject to the layoff provision and other provisions set forth herein.
- 3. Employment Responsibilities. The certified staff member shall perform the duties and responsibilities of the assigned teacher position to a standard of quality and effectiveness as that established in District policy and ordinarily required of the profession. The certified staff member shall attend meetings and professional development activities as may be required by the District. The certified staff member agrees to accept pupil supervision or other assignments as may be required by the District. The certified staff member is subject to all District policies, procedures, rules and regulations and the certified staff member agrees to comply with the same.
- 4. Compensation. In consideration for the services rendered, the certified staff member is to be paid a total salary of \$\$\$\$\$, which includes a base salary (see additional sheet attached) for the term of this contract. The Board and the certified staff member acknowledge and agree that the annual salary of certified staff member in subsequent contract years may be increased or decreased in conformance with the Certified Staff Compensation Model adopted by the Board. The Board may provide the certified staff member with other employment benefits that it may from time to time deem appropriate for certified staff generally, as specified in Board policy, administrative rule or the Employee Policy Manual. Nothing in this contract is intended to guarantee the continuation of any benefit and the certified staff member acknowledges that the Board reserves the right to add, to modify and/or eliminate benefits as it deems appropriate for the District.

The certified staff member may elect to receive salary in equal installments paid over a twelve month period by written request to the District's Human Resources Department made on or before September 1, 2014. If this election is chosen, the certified staff member's salary will be paid in 24 equal installments in accordance with the District's payment policies for work commencing on the first school day. Once made, the election to receive salary over twelve months cannot be revoked.

5. Licensing. This Agreement is conditioned upon the certified staff member's possession of a valid State of Wisconsin license or certificate as required by the laws of the State of Wisconsin for the performance of services assigned by the District. This Agreement shall automatically terminate by its own terms in the event that license or certificate is not current, and/or is invalid, suspended or revoked, unless otherwise determined by the District.

- 6. Termination; Effect of Termination.
- (a) Teacher may terminate this Agreement prior to the termination date set forth in section 1 by providing 30 calendar days' advance written notice to the District, provided, however, that such early termination shall result in the certified staff member's loss of any accrued leave benefits that would otherwise be payable to the certified staff member. The certified staff member will be required to pay back any advance payments or other amounts owed to District, if any, which District may, at its option, set-off against any amounts owed by District to the certified staff member. In the event the certified staff member terminates this Agreement without providing 30 calendar days' written notice to the District, the certified staff member shall pay to the District liquidated damages as outlined in the Employee Policy Manual.
- (b) The District may terminate this Agreement prior to the termination date set forth in section 1 in the event that the certified staff member violates a District rule, policy, procedure, employee policy manual, established performance expectation or expected standards of conduct as determined by the Board of Education for non arbitrary or capricious reasons. If the District terminates this Agreement under this subsection 6(b) and the certified staff member wishes to contest such termination, the certified staff member must file a grievance under the District's grievance procedure. The grievance shall be heard by an impartial hearing officer who will have authority to render a decision with respect to a grievance in accordance with the District's grievance procedure. The grievance procedure is an alternative dispute resolution procedure and it is agreed that it will be the exclusive method for resolving all disputes regarding terminations made under this subsection 6(b).
- (c) This Agreement shall terminate upon the death of the certified staff member. In the event of the certified staff member's disability, the Agreement shall be subject to the District's policy on long-term disability.
- (d) Renewal or Non Renewal of this Agreement will be governed pursuant to the provisions of Section 118.22, Wisconsin Statutes, at the will of the Board of Education.
- 7. Layoff. The Board of Education reserves the right to lay off the certified staff member during the term of this Agreement based upon the needs of the District in accordance with the policies of the District concerning reductions in force. The certified staff member shall be given notice of such layoff not less than thirty (30) calendar days prior to the effective date of such layoff. It is understood that as a layoff, the non-renewal procedures of Section 118.22, Wis. Stats., do not apply.
- 8. Miscellaneous. In the event that any provision of this agreement is determined by a court of competent jurisdiction to be invalid, all other provisions of this agreement shall remain in full force and effect. District's failure to insist upon the performance of any obligation or its failure to exercise rights under this Agreement shall not constitute a waiver as to future defaults or exercise of rights. This Agreement is governed by and shall be construed in accordance with the laws of the State of Wisconsin. This Agreement constitutes the complete understanding between the Teacher and the District and shall supersede all prior agreements, understandings or practices, whether oral or written. Any amendments to this Agreement must be in writing and signed by authorized representatives of both parties.
