

546 **Wellness** -- In order to fully achieve the mission of the Neenah Joint School District, we recognize our responsibility to promote lifelong wellness behaviors that link proper nutrition and physical activity to students' overall health, growth, development, academic performance, and readiness to learn. We aim to promote the same healthy behaviors to staff as well, to serve as role models for the students and enhance their own health and productivity. This District-wide wellness policy encourages all members of the school community to create an environment that supports lifelong healthy eating habits and promotes opportunities for increased physical activity.

546.1 **Wellness Goals**

546.11 Establish an environment that empowers the school community to make good **healthy** nutritional choices during the academic day and school-related functions outside of the instructional day.

546.12 Establish an environment that empowers the school community to ~~increase~~ **engage in** physical activity during the academic day and supports the continuation of these activities outside of the instructional day.

546.13 Provide a high quality lunch program for students and staff.

546.131 Provide students and staff with well-balanced nutritional choices of food and beverages;

546.132 Assist students in making healthy choices; and

546.133 Encourage and promote participation in the school lunch program.

546.14 Educate our school community, including students, parents and staff, on the benefits of good **healthy** nutrition and physical activity.

546.15 Support a safe environment for students and staff.

546.2 **Nutrition ~~Standards~~ Guidelines**

546.21 **Foods and Beverages** - Students and staff are encouraged to consume a variety from each of the five food groups according to the USDA recommendations **as well as consume water throughout the day.** ~~of servings on the Food Pyramid. Additionally, students and staff are encouraged to consume foods that contain low sugar, low sodium, low saturated fats and zero trans fat, and those rich in nutrients such as whole grains, dairy, lean protein, and fresh fruits and vegetables.~~

~~546.211 Food items will have no more than 30% of their total calories derived from fat and no more than 10% of their calories derived from saturated fat. Nuts, seeds, and their derivatives are exempt when consumed in small quantities due to their nutrient density and levels of monounsaturated fat.~~

~~546.212 The consumption of nutrient-dense foods which provide students with calories rich in nutrient content needed for good health, e.g. whole grains, fresh fruits, and vegetables is encouraged.~~

~~546.22 **Beverages** – The District will encourage students and staff to increase their consumption of water throughout the day. Other beverages that are appropriate~~

~~546.221 Non-carbonated or sparkling water containing no calories or sugar, but may contain natural flavorings~~

~~546.222 Milk, soy beverages, rice beverages or other similar dairy and nondairy beverages~~

~~546.223~~ 100% fruit juices or fruit based drinks that do not contain added sugar

~~546.224~~ An electrolyte replacement beverage that contains 20 g or fewer of additional sweetener per serving

546.3 District Food Service

546.31 The goals of the food service program are:

546.311 **To provide students and staff with well-balanced nutritional choices of foods and beverages.** The District will continually expand and explore menu offerings based on nutritional content and student preferences. The food service program will **comply with and** strive to exceed the minimum nutritional guidelines required by the National School Lunch Program. **Proactively working toward the 2014-15 National School Lunch Program standards, the food service program will increase offerings of nutrient dense foods and reduce the number of foods with limited nutritional value.** ~~A healthy~~ The a la carte program ~~should~~ **will** include ~~low-fat~~, nutrient dense foods.

546.312 **To assist students and staff in making healthy choices.** Students, staff, and parents will be educated about proper nutrition. The food service program will offer, promote, and display food items high in nutritional value. ~~Candy, food or beverages of minimal nutritional value will not be offered.~~

546.313 **To encourage and promote participation in the school lunch program.** Administrators, staff, parents, and students will work with the food service program to promote participation in school lunches. The District will provide a clean and pleasant eating environment for students and staff, with adequate space and appropriate time for eating (at least 20 minutes for student lunches, from the time seated, is recommended) and access to hand washing facilities.

546.32 The food service program will use and provide fresh fruits and vegetables instead of canned or processed products whenever possible.

546.33 Students and staff who bring lunches from home are encouraged to make healthy choices and bring water or 100% juice instead of heavily sweetened juice and sport drinks. Purchasing milk will also be an option.

546.34 Parents who choose to send cold lunches are strongly encouraged to send ~~low-fat~~, nutrient dense foods.

546.4 ~~Low-fat~~, High Nutrient Lunch and Snack Recommendations

546.41 Whole grain breads, wraps, pitas, bagels, crackers, muffins, granola bars or ~~cookies~~

546.42 Fresh Fruit and 100% fruit juices

546.43 ~~Low-fat~~ dairy products **including light yogurt, white milk, and string cheese**

546.44 Proteins (peanut butter, cheese, lean meats)

546.45 Salads and raw vegetables with low fat dressings

546.46 Dried fruits (raisins, banana chips, etc.)

546.47 Dry roasted peanuts, tree nuts, **seeds**, soy nuts and party mix

546.48 Trail mix (dried fruits and nuts)

546.221 Non-carbonated or sparkling water containing no calories or sugar, but may contain natural flavorings

546.222 Milk, soy beverages, rice beverages or other similar dairy and nondairy beverages

546.223 100% fruit juices or fruit-based drinks that do not contain added sugar

~~546.49 Sugar-free gelatin and low-fat pudding cups~~

546.5 **School-Based Activities**

546.51 The District will create a school environment that promotes healthy food and beverage choices during the school day and at school-related functions outside the instructional day.

546.52 District employees will promote the School Wellness Policy and are encouraged to serve as positive role models for students, parents, and fellow staff members.

546.53 Classroom/School Activities

546.531 At any school-sponsored function during or after the instructional day, healthy food choice options will be available. (See District Lunch and Snack Recommendations.)

546.532 Strong consideration should be given to non-food items as part of any student incentive programs. Any food items used as incentives must ~~meet District nutrition standards.~~ **contain low calories, low sodium, and low saturated fats and zero trans fat.**

546.533 For individual classroom celebrations and other events **during the school day**, ~~parents and teachers will provide~~ **only** healthy snacks (see District Lunch and Snack Recommendations) **and/or** non-food treats (stickers, pencils, rulers, erasers, books, bookmarks, etc.) **are allowed.**

546.54 Beverages

546.541 Vending machine sales of soda or artificially sweetened (such as; NutraSweet®, Splenda®, or Equal®) drinks will not be permitted on school grounds.

546.542 Vending machine sales of beverages, other than soda, with less than 10% fruit juice may begin at the conclusion of the instructional day.

546.543 Non-vending machine sales of soda or artificially sweetened (such as; NutraSweet®, Splenda®, or Equal®) drinks will not be permitted on school grounds both prior to the start of the school day and throughout the instructional day, but will be permitted at special school events that begin after the conclusion of the instructional day.

546.544 Milk (skim, 1%, 2%, in plain, chocolate, and strawberry), water, and 100% juices may be sold on school grounds prior to, throughout and after the instructional day.

546.55 Candy

546.551 Candy is considered to be any food which contains empty calories, provides no nutritional value, and has sugar listed as one of the first two ingredients, including, but not limited to, brown sugar, corn

sweetener, corn syrup, fructose, glucose (dextrose), high-fructose corn syrup, honey, invert sugar, lactose, maltose, molasses, raw sugar, table sugar (sucrose), and syrup.

546.552 Vending machine sales of candy will not be permitted on school grounds.

546.553 Non-vending machine sales of candy or products with greater than 35% sugar by weight will not be permitted on school grounds both prior to the start of the school day and throughout the instructional day, but will be permitted at special school events that begin after the conclusion of the instructional day **provided that healthy alternatives are also available. School stores are required to follow this policy.**

546.56 Fundraising

546.561 Fundraising of any type requires administrative approval and **must should** include healthy choices.

546.562 Suggested fundraising sale item alternatives include, but may not be limited to, books, gift wrap, candles, plants, school promotional items, fruit, etc.

546.6 Physical Activity and Nutrition Education

546.61 The District will increase activity and health-related fitness knowledge in both Wellness Education and in the school environment through organized curriculum.

546.62 Physical Activity

546.621 The Wellness Education Program incorporates best teaching practices into class activities and modules to teach students the importance of physical activity. Students are exposed to a wide variety of activities so they can develop the knowledge and skills to be physically active for life.

546.622 Students receive instruction in the five health-related components of fitness (cardiovascular health, muscular endurance, muscular strength, flexibility, and body composition). Body composition instruction focuses on teaching the relationship between healthy eating and activity.

546.623 In grades K-5, classroom teachers will engage the students in fitness activities for 15 minutes twice a week. This will meet the DPI's requirement for offering a third class in wellness education.

546.624 The District will promote healthy, activity-based wellness behaviors by promoting school and classroom activities in established programs and activities.

546.625 The District will extend fitness and wellness knowledge activities beyond the school into the home and community settings. To accomplish this, the District will coordinate activities such as wellness fairs, guest speaker presentations and open houses. Information about these activities will be shared through school and classroom newsletters.

The District will offer fitness education to employees (newsletter, presentations, challenges, etc.)

546.63 Nutrition Education

546.631 The District has a comprehensive nutrition curriculum in all grades. It has adopted state performance standards and learner objectives emphasizing good nutrition, disease prevention and healthy lifestyles. These objectives can be found within the Wellness Education, Health, Guidance, and Family and Consumer Science curricula. These objectives provide students with the knowledge, attitudes, skills and behaviors for lifelong healthy eating habits and physical activity.

546.632 Topics covered, as part of this curriculum, include but are not limited to: eating habits, nutrients, dietary guidelines, food guide pyramid, serving sizes, labeling, weight management, eating disorders, fad dieting, food safety, food allergies, and food sensitivities.

546.633 The District also encourages faculty at all grade levels to incorporate nutrition education, wellness, and physical activity into other courses offered.

The District will offer nutrition education to employees (newsletter, presentations, challenges, etc.)

546.7 Monitoring and Evaluating the Wellness Policy

546.71 The District will maintain a Healthy You! Team, which will monitor the implementation of the District's wellness policy, evaluate the progress of related goals, serve as a resource to school sites, plan special events and incentives, and recommend policy revisions as necessary.

546.711 The Team will meet at least biannually, and can include the Director of Business Services, Supervisor of Food Service, district administrators, building principals, Board of Education members, community members, dietitians, students, parents, and staff members from each school level.

546.712 The ~~Committee~~ Team will keep the Board of Education informed about progress towards the goals outlined in the District Wellness Policy.

546.72 The District website, along with other forms of communication, will be used to inform the community of the District Wellness Policy.
